\* Currently we have 99 out of 115 Head Start slots filled. Head Start is aware of the challenges that all Head Start programs are currently facing and are just asking that we document our enrollment. We will continue our recruitment efforts, however we will not be penalized if we do not fill our 115 Head Start Slots.

\*If students qualify for Head Start they also qualify for state pre-k.

**Attendance Rates ending 8/31/23:**

Head Start requires that average daily attendance is at 85% monthly.

- Average Daily Attendance for Head Start Students only was 94%
- Average Daily Attendance for all students in the program was 95%

**Wait List as of 8/31/23**

There are currently 9 students on a waitlist for the program. While not all of our classrooms are full we do need to leave a certain amount of slots open as we currently still need to fill 16 head start slots to meet our Head Start funded enrollment of 115.

We are required to conduct Hearing and Vision Screenings within the 1st 45 days of students attending class. Health and Vision screenings are scheduled to take place this month Physical and Dental examinations along with Immunizations on all students should be completed within 90 days of students attending class.
